

June 18, 2014 Regular Town Board Meeting

The regular meeting of the Town Board was called to order by Chairman Gaulke at 3:00 p.m. Supervisors Ginger Schwanebeck, Treasurer Irene Messinger and Clerk Nancy Edwards were present. Mr. Hoover was out of town.

This meeting was properly posted and the media notified as required by law.

Motion by Mrs. Schwanebeck and seconded by Mr. Gaulke to approve the agenda. The motion carried.

Motion by Mrs. Schwanebeck and seconded by Mr. Gaulke to approve voucher numbers 46887-46911 from the General Fund account, vouchers 1598-1599 from the Ambulance Fund account. Motion carried.

Motion by Mrs. Schwanebeck seconded by Mr. Gaulke to approve the minutes of the June 4, 2014 Regular Town Board meeting. Motion carried.

Treasurer Messinger provided her report on the financial status as follows: Un-reconciled balance of the General fund as of 06/15/2014 as 672,737.04. Un-reconciled balance of the Ambulance Fund as of 6/15/2014 as \$297,595.90. Motion by Mrs. Schwanebeck seconded by Mr. Gaulke to accept the treasurer's report as presented. Motion carried.

**Liquor License Applications:** The liquor applications for the 2014-2015 licensing period were reviewed for approval. These applications were also presented to the Joint Town and Liquor Committee for approval. Motion by Mrs. Schwanebeck seconded by Mr. Gaulke to approve the license applications with the exception of Crickets Pub & Café' because a valid sellers permit is required by the Department of Revenue, and Gordon & Diane's Bar as some outstanding invoices need to be taken care of. Motion carried. The board has scheduled a Special Town Board meeting on Monday June 30, 2014 at 10:00 a.m. to address these two applications which hopefully will have the proper paperwork so they may be approved.

**Bartenders License Applications:** Bartenders applications were received from Jason J. Austin, Alicia A. Maki, Jenette A. Potts, Carla Rose Winters, Audrey Maulson, Mary Poupert, Chris J. Motion by Mrs. Schwanebeck seconded by Mr. Gaulke to approve all the applications as presented with the exception of Candace Maulson and Justin P. Wolfe. Motion carried.
