## **Chapter 1** Issues and Opportunities

This chapter- the first of nine chapters of the Town of Lac du Flambeau Comprehensive Plan- explores potential issues that may have an effect on the development of the Town over the 20- year planning period of the plan. As required by the state's comprehensive planning law [66.1001(2)(d) Wis. Stats.], this chapter contains trends and forecasts with jurisdictional comparisons for some basic demographics including: population, households, employment, age, education, and income. Although forecasts should typically cover the 20-year planning period, in some cases, the only acceptable sources had lesser time periods for their forecasts. Official sources are used for data and forecasting, including the WDOA Demographic Service Center, and the U.S. Census Bureau.

## C. DEMOGRAPHICS

The following demographic information came from the U.S. Census and the Wisconsin Department of Administration (WDOA) Demographic Service Center. The Town of Lac du Flambeau and the Lac du Flambeau Band of Lake Superior Chippewa (known as the Tribe) share jurisdiction within the Town boundaries. The U.S. Census provides information for all residents within the Town (Tribal and non-Tribal), and Tribal residents within the Reservation that extends outside of the Town. Ethnicity was used for reference to separate the two groups of Town residents for some data sets. The WDOA only has total Town resident projections. Even if the U.S. Census data could be separated, there is no way to isolate Tribal and non-Tribal residents among WDOA projection data.

## 1. POPULATION TRENDS AND FORECASTS

Between 1990 and 2010, the Town of Lac du Flambeau's population increased by about 41%, see table 1. Minocqua and Arbor Vitae both shared similarly strong growth over the last 20- years with Lac du Flambeau. Not all surrounding towns had the same strong growth. Mantowish Waters is the only town with a decreasing population. Vilas County has grown much faster than the State with respective growth rates of 21.0% and 16.3% over the last 20 years.

Population projections in Table 2 show the town of lac du Flambeau growing a total of 18.85% over the next 20- year period between 2010-2030. Based on these estimates the town of Fifield is the only town that is expected to decrease in population.

## 2. HOUSEHOLD TRENDS AND FORECASTS

The 3,441 residents of the Town of Lac du Flambeau formed 1,269 households in 2010. Total households are projected to increase to 1,640 by 2030, see Table 3. This reflects the population growth projected in Table 2. Average household size in Lac du Flambeau was 2.71 people in 2010, which is higher than the 2.43 State averages. Table 3 reflects an overall trend of fewer people per household and projected population changes.

## 3. AGE DISTRIBUTION

In 2000, the median age of Lac du Flambeau's population was 37.3 years. At that time, residents of the County had a higher median age of 45.8 years. Both the town and the County had populations older than the state (36 years) as a whole. The Town of Lac du Flambeau had a slightly lower proportion of working age population (18-64) than the county and state. The percentage of children aged <5, and 5 to 17 were slightly higher than the county and state age distributions.

By 2010, the median age of the population in the Town had advanced by 2.4 years; which is less than the County (11 years) and more than the state (1.2). The Town's median age is only slightly above the state, but many of the surrounding towns have significantly higher median ages.

The proportion of working age (18-64) population decreased slightly for the Town, county and state between 2000 and 2010. During the same time period, the proportion of the population aged <5 years increased dramatically in the Town, while all other areas decreased slightly. The percentage of children aged 5-17 decreased slightly while the percentage of adults aged 65+ increased slightly. The state and county generally changed very little.

Figure 1 displays the population pyramid for the Town. A snap shot of age groups s seen of the combined native and non-native populations as of 2010. A strong burst of youth from under 5 to 24 years old shows that this town will not going to decline residentially. The Town also has a large population of 45 to 74 year olds.

Figure 2 represents the non-Native American population that lives within the town boundaries. This population pyramid shows that many older people exist in town than younger people. Older people appear to have migrated to the town according to this figure.

Figure 2 2010 Age Cohorts for NON-NATIVE Town of Lac du Flambeau Residents





Figure 3 represents the Native American population that lives within the town boundaries. This population pyramid shows that many young families exist, and are having children to replace the naturally declining older population.

#### 4. EDUCATION LEVELS

The educational attainment level of persons within a community is often an indicator of the overall income, job availability and well-being of a community. In 2000, about 90% of the Town of Lac du Flambeau's population age 25 and over were high school graduates, compared to 91% in the County and 89% in the state. By 2016, high school graduation has declined to 87% in the Town, but has increased to 92% in the county and 91% in the state. See Table 5 for details.

## 5. INCOME LEVELS

In 2010, the median household income for the Town was 4% lower than the County and about 29% lower than the state. On a per capita basis, the income of Lac du Flambeau's residents was 16% lower than the County and about 14% lower than the state in 2010.

In 2016, the median household income for the Town was 31% lower than the County and about 72% lower than the state. On a per capita basis, the income of Lac du Flambeau's residents was 16% lower than the County and about 24% lower than the state in 2016. While median household income declined in the Town of Lac du Flambeau from 2010 to 2016, the per capita income increased slightly.

#### **CHAPTER 4**

## **UTILITIES AND COMMUNITY FACILITIES**

This chapter- the fourth of nine chapters of the Town of Lac du Flambeau Comprehensive Plan- is based on the statutory requirement for a compilation of objectives, policies, goals, maps and programs to guide future development of utilities and community facilities. As required by the state's comprehensive planning law [66.1001(2)(d) Wis. Stats.], this chapter inventories existing public utilities and community facilities and assesses future needs for such services including those beyond the control of the Town located outside the community and/ or under another jurisdiction. Parks are also located in this chapter.

#### C. INVENTORY & ANALYSIS OF EXISTING FACILITIES

This chapter- the fourth of nine chapters of the Town of Lac du Flambeau Comprehensive Plan- is based on the statutory requirement for a compilation of objectives, policies, goals, maps and programs to guide future development of utilities and community facilities. As required by the state's comprehensive planning law [66.1001(2)(d) Wis. #### 7. EMERGENCY SERVICES

## Fire

The Town maintains its own volunteer fire department with two fire stations. Fire station #1 is located at 614 Wild Rice Avenue (see MAP 5), and Fire Station #2 is located in the southeast part of town at 13145 Firehouse Lane (see MAP 4). Both fire stations contain an ambulance.

Insurance Services Office's (ISO's) Public Protection Classification (PPC™) program is used by fire insurance companies to assess the fire risk in a community. ISO's PPC™ is rated on a class scale of 1 to 10, with Class 1 representing the best protection and Class 10 representing an essentially unprotected community.

The Town of Lac du Flambeau currently has the following ISO PPC™ ratings:

- Class 6- within 5 driving miles of Fire Station #1;
- Class 7- within 5 driving miles of Fire Station #2; and
- Class 10- in all areas more than 5 driving mile from a fire station.

Mutual aid exists with the surrounding communities.

## 11. OTHER GOVERNMENT FACILITIES

The local road system is the most significant public facility maintained by the Town and is covered in the Transportation Chapter. The Lakeland Airport/ Noble F. Lee Memorial Field (ARV) is another major public facility also covered in Chapter 3- Transportation.

## Chapter 6 Economic Development

This Chapter- the sixth of nine chapters of the Town of Lac du Flambeau Comprehensive Plan- is based on the statutory requirement for a compilation of objectives, policies, goals, maps and programs to promote the stabilization, retention or expansion of the economic base and quality employment opportunities in the Town. As required by the state's comprehensive planning law [66.1001(2)(d) Wis.

Stats.], this chapter analyzes the labor force and economic base, ensures designation of adequate sites for business and industry, evaluates potentially contaminated sites for reuse, and identifies applicable county, regional and state economic development programs.

## C. ECONOMIC BASE AND LABOR FORCE ANALYSIS

Historically the Arts, Entertainment, Recreation, Accommodation, and Food Service industry has been the strongest sector in Vilas County, with 1,791 workers in 2010, but has declined to 1,581 by 2016. Table 16 shows that the wholesale trade industry increased by 73 percent (111% within the Town) between 2010 and 2016.

According to the 2010 Census, the civilian labor force (population 16 and over) living in the Town of Lac du Flambeau was approximately 1,356 workers. Of this labor force, there were 242 people unemployed for an unemployment rate of 9.1 percent. The unemployment rate in 2016 was 6.8 percent.

Along with Vilas County in 2016, Lac du flambeau has three primary occupations; management, professional and related; service; and sales and office, see Table 15. The leading industry sectors in the Town as of year 2016 are: education, health and social services; arts, entertainment, recreation, accommodation, and food services, see Table 16. Both industry sectors had over 250 workers each, with no other industry sectors coming close.

Tables 15 and 16 data are based on the number of workers residing in the Town and what they do for employment not where they are actually employed. Information regarding the number of jobs available in the Town of Lac du Flambeau itself is not readily available. The largest employer is the Lac du Flambeau Band of Lake Superior Chippewa, which operates a casino and governmental offices in the Town. There is also one K-8 grade school in Town.

Employment forecasts are difficult to come by and not available at the town level. However, the U.S. Census Bureau prepares 5 year estimates through the American Community Survey. Table 15 and 16 contain data from the 2010 Census and the 2012-2016 American Community Survey 5- year estimates.

#### **CHAPTER 7**

## **LAND USE**

This chapter- the seventh of nine chapters of the Town of Lac du Flambeau Comprehensive Plan- is based on the statutory requirement [66.1001(2)(d) Wis. Stats.] for a compilation of objectives, policies, goals, maps and programs to guide the future development and redevelopment of public and private property. This chapter lists existing land uses in the Town and provides 20-year projections in 5-year increments for the various land uses.

# **B. EXISTING LAND USE INVENTORY, 2018**

# **Land Values**

Overall equalized land values in the Town have decreased about 11.6 percent over the last seven years; however not all categories of land decreased equally. Agricultural property values increased by 29.7 percent, while other, manufacturing and forest increased by 8.8, 3 and 2.1 percent respectively. See TABLE 20, Equalized Property Value, below.
