Supervisor Hanson suggested appointment of interim chief with a search to fill the position. Discussion. Supervisor Hanson's motion failed to due lack of a second. <u>Discussion/Possible Action: Fire and Ambulance Monthly Stats Report, Ambulance Data:</u> Mike Zimmerman read the July stats. Jim Sommerfeldt made comments regarding ambulance certification, WARDS system tracking, and it's use to the fullest extent, Lifequest contract and accountability, audit of the public safety departments. His desire to possibly have the chief become a paid position in order to have better reporting on runs, apparatus use; taking a deep dive into the management role and record keeping. Concern of the OCEMS contract is still a factor in future planning.
